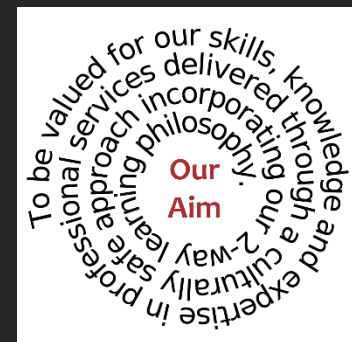

There are only 32 identified Aboriginal Accountants across a membership base of around 160,000 accountants.

With the introduction of the Government's Indigenous Procurement Policy we understand that the opportunity for Indigenous business is increasing. This means that there are more and more Indigenous businesses commencing and growing.

As this happens the need for accountants to assist in these businesses is also growing.

Our goal is to establish a pipeline of work that will allow us to recruit and train Aboriginal and Torres Strait Islander Accountants to work with us in our industry sectors, so that they can take these skills into these new businesses.
